Beaufurn reserves the right to make changes to the products represented in the lines without prior notice to customers. We continually make modifications to structure and dimensions to improve the comfort and look of our items. Dimensions listed are approximate and can vary per item. Please do not assume that a style will have the exact dimensions shown. If you have specific dimensional needs due to limited space, etc please notify Beaufurn at time of order.

COM

All upholstered items are priced as COM, Customer's Own Material, unless otherwise specified in the price list. Beaufurn offers a limited selection of top quality upholstery fabrics. Please contact customer service for pricing and colors available. Beaufurn is not responsible for color accuracy, defects, performance, durability, appearance or flame retardancy of COM. All COM fabrics sent must pass CAL TB-117-2013, and documentation for confirmation must be supplied. However, if the fabric was produced prior to 1/1/15 and passed a similar test method (ASTM, UPFAC or NFPA 260) that is also acceptable. Otherwise, if no certifications or proof of compliance are provided, a barrier can be applied to the material as long as documentation is provided that the barrier meets Section 2 of TB117-2013. COM is not covered under Beaufurn's Limited Warranty. Beaufurn reserves the right to refuse any COM deemed unsuitable for upholstery. Yardage requirements shown in price list are for non-directional fabrics based on 54" wide fabric. In the absence of instructions, we will apply a fabric pattern according to our best judgment. Please ship all COM to Beaufurn and include the order number, customer name and item number the fabric is to be applied to. COM not received within one week of payment with an order, will further delay your order. Your order will be placed on hold and withdrawn from the production queue until we can receive your COM. Once COM is received, your order will be released back into production as quickly as possible.

FREIGHT COSTS | GUARANTEED SHIPPING + HANDLING PROGRAM

PROGRAM - Beaufurn offers an optional guaranteed shipping and handling program. Delivery is via common carrier. Shipping and handling charges are pre-calculated and prepaid by Beaufurn, and added to the original invoice at the time of shipment. This optional guaranteed shipping and handling program enables the purchaser to determine shipping and handling charges when ordering and provides the purchaser with one invoice for both shipping and handling charges, and the Beaufurn product.

HOW TO USE - Unless otherwise noted on your order, Beaufurn will ship "Guaranteed Shipping," and will select the most appropriate carrier and routing on all shipments. If the customer specifies a carrier on their order, freight will ship collect via that carrier.

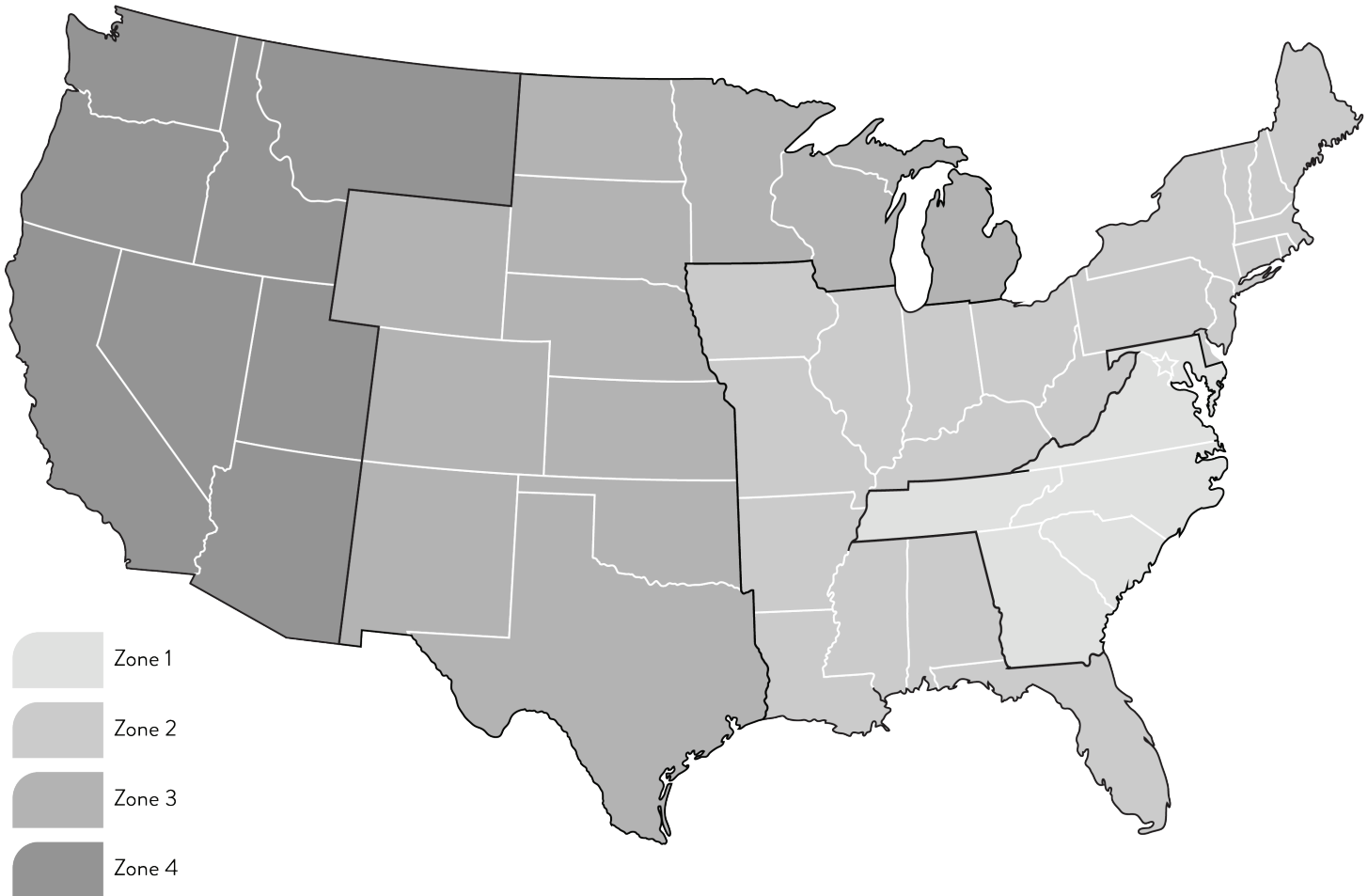

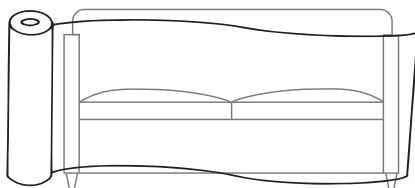

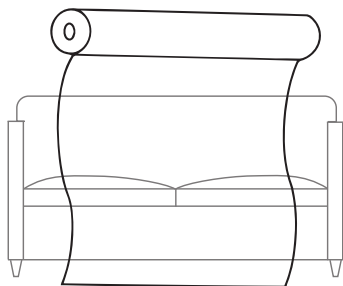

RETURNS

Please review Beaufurn's Terms and Conditions of Sale and Limited Warranty for specific information on returns, liability and more detail on any of the above issues.

Lounge

LIMITED LIFETIME WARRANTY against manufacturing and materials defects on the frame, springs, and decking materials for the useful life of the product, if item is still in its original state without modifications.

FIVE-YEAR WARRANTY against manufacturing and defects following the invoice date on foam cores and reclining mechanisms if the item is still in its original state without modifications. Foam to be free from manufacturing defects and against the loss of foam resiliency. Fiber wraps, used to create loft and surface smoothness will, over time, lose some of its initial loft; therefore, some softening and flattening of the foam core and fiber wraps should be expected and will not be considered defective.

Dining Chairs

FIVE-YEAR WARRANTY against manufacturing and materials defects following the invoice date on the frame, foam, and decking materials, if item is still in its original state without modifications.

TWO-YEAR WARRANTY against manufacturing and materials defects following the invoice date if item is still in its original state without modifications.

Tables, Occasional Tables, Case Goods

ONE-YEAR WARRANTY against manufacturing and materials defects following the invoice date if item is still in its original state without modifications.

Removable Seat Deck

Many Senior Living by Beaufurn seating includes a removable seat deck as a standard feature to help facilitate cleaning in contract environments. There is no additional upcharge. Note, there are a handful of exceptions where fixed seats are integral to product design and structural integrity. Individual items that are produced with fixed seats are noted in the price list.



Seat Cushions

Seat cushions are available in two construction options. Contract cushions are standard. Non-contract cushions, which provide a “softer” seat, are available as an option and must be specified on the purchase order. There is no additional upcharge.

Contract Cushion (standard) – comprised of 35lb / 2.5 density foam

Non-Contract Cushion (optional) – comprise of 25lb / 1.8 density foam

Multiple Upholstery Cover Application

Nearly all products can be manufactured with a combination of upholstery cover materials (i.e., vinyl and fabric, leather and fabric, multiple fabrics). If specified, multiple upholstery cover application should be clearly indicated on the purchase order. Upcharges are calculated as follows:

Graded-In: When multiple upholstery materials are specified that fall into different grades, please use pricing for the highest grade plus the additional cover upcharge(s) per piece.

COM: When multiple COMs are specified, please add the additional cover upcharge(s) per piece:

Lounge Chairs - \$80 LIST per additional cover material per piece

Loveseat - \$110 LIST per additional cover materials per piece

Sofa - \$135 LIST per additional cover material per piece

Dining/Arm Chair/Barstools - \$30 LIST per additional cover material per piece

Moisture Barrier

Moisture barrier is produced to prevent moisture from penetrating the foam and other filling materials. Moisture barrier is applied between the upholstery cover and filling materials. The upcharges below apply to each surface on which the protective barrier may be applied.

TERMS & CONDITIONS

TERMS & CONDITIONS

The sale or supply of any products and/or services by Seller, or its subsidiaries or affiliates, to the Purchaser is expressly conditioned upon the terms and conditions contained or referred to in this Contract. Any additional or different terms and conditions set forth in Purchaser's purchase order or other communication are objected to and will not be binding upon Seller unless specifically agreed to in writing by an officer of Seller. Any order or authorization by Purchaser, whether written or oral, for Seller to furnish products or services shall constitute acceptance of these terms and conditions. No modification to this Contract shall be effective against Seller unless evidenced in writing and signed by a duly authorized representative of Seller.

1. Definitions: "Seller" shall mean Beaufurn, LLC; "Purchaser" shall mean the person or entity listed on the order acknowledgment, and any subsidiary or affiliate of such person or entity receiving Products under the Contract; "Parties" shall mean the Purchaser and Seller, collectively; "Product(s)" shall mean the goods supplied pursuant to this Contract; "Contract" shall mean Beaufurn's order acknowledgment, these Terms and Conditions, and the Limited Warranty; and "Facility" shall mean any manufacturing or distribution facility operated by Seller.

2. Method of Payment: A 50% deposit is due from the Purchaser at the time of order of any Product. The balance is due before shipment of the Products and/or when the Products are ready to be shipped. All payments shall be paid in United States Dollars and may be payable via cash, check, wire, ACH, or credit card only.

3. Delivery and Risk of Loss: All prices of Products are Ex Works (Incoterms 2000) Seller's Facility in North Carolina. Title to and risk of loss of any Products sold hereunder shall pass to Purchaser upon Seller's delivery of the Products to the carrier at Seller's Facility. Seller is not responsible for loss or damage in transit. Purchaser shall bear the cost of freight from Seller's Facility to Purchaser's location. Performance shall be deemed to have occurred at the point of delivery to carrier at Seller's Facility.

4. Acceptance and Rejection: Promptly upon receipt of Products delivered hereunder, Purchaser shall carefully inspect such Products for any damage, defect, or shortage before signing the freight bill. All claims for shortage or nondelivery and any claim for damage or defect which could reasonably be discoverable in the course of such inspection shall be waived unless Purchaser shall notify Seller of the same within five (5) days after receipt of such shipment of Products to which the claim relates. If Purchaser rejects in whole or in part any nonconforming shipment of Products, Purchaser shall provide Seller written notice of such rejection not later than five (5) days after receipt of such shipment of Products. If Purchaser fails to provide Seller with such notice, Purchaser shall be deemed to have accepted the applicable shipment of Products. Upon written notice of nonconformity of any Product, Seller shall have the right to cure said nonconformity within a reasonable time. If Seller agrees with Purchaser's determination that a shipment of Products does not comply with applicable specifications, Seller shall use reasonable efforts to repair or replace the nonconforming Products, at no additional costs to Purchaser.

5. Product Specification and Prices: Seller reserves the right to alter product specifications without notice. Prices are subject to change without notice to Purchaser. All orders placed by Purchaser are subject to final confirmation by Seller. Seller is not responsible and will not honor incorrect quotations from independent representatives. All prices and other terms are subject to correction for typographical or clerical errors.

6. Product Dimensions: All advertised Product dimensions are subject to change without notice to Purchaser or Purchaser's consent. If dimensions are critical to Purchaser, Purchaser may advise Seller of such when ordering the Product(s). Seller will make reasonable efforts to comply with Purchaser's requests, however, Seller does not guarantee that the Product(s) will exactly conform to Purchaser's requests or the advertised dimensions.

7. Cancellations: All Products are finished to order and Purchaser shall have no right to cancel an order without first obtaining the prior written consent of Seller and the payment of the cancellation fee imposed by Seller. Seller will not consent to the cancellation by Purchaser of an order after production of such Products has begun.

8. Seller's Right to Sell Product: Possession of Seller's catalog and price list does not constitute authority to purchase or sell Products manufactured by Seller. Seller sells Products on a select dealership basis and reserves the right to decline orders from any prospective Purchaser or account.

9. Collection Costs: Purchaser agrees to be liable for all collection costs including, but not limited to, Seller's attorney's fees and costs. 11. Storage Charges: Postponement of shipment beyond Seller's scheduled ship date will result in a storage charge at the rate of two and one-half percent (2.5%) or Prime Rate + 1% whichever is higher per month on invoice total.

12. Minimum Order: Minimum quantity order may apply on some Product styles.

13. Taxes: Purchaser shall pay all taxes based on or in any way measured by this Contract or the Products, including any real or personal property taxes. If Seller is required to pay or collect any taxes on the Products, then all such amounts shall be paid by Purchaser or reimbursed by Purchaser to Seller.

14. Products Including Marble: For Products incorporating marble, Purchaser acknowledges and agrees that even though marble tops are anti-stain treated prior to leaving the factory, marble is a porous material and food or liquid stains may occur if they are not removed immediately after happening. Purchaser further acknowledges that Seller recommends that marble tops be re-treated with anti-stain at least twice a year using commercially available products. Purchaser acknowledges that marble is a natural product and will show natural variations in color and composition.

15. Table Top and Table Base Product: Purchaser acknowledges and agrees that recommended table top/base sizes are for reference only. It is Purchaser's sole responsibility to confirm sustainability for specific applications.

16. Products with Wood Finishes: Purchaser acknowledges and agrees that due to natural variations in the color of wood in its unfinished state, Products with wood finishes may show slight variations in color from any samples provided for review.

17. Products made with Purchaser's Own Material ("COM"): COM will be scheduled for production only after receipt and inspection of the COM by Seller. Purchaser acknowledges and agrees that in COM orders the actual yardage required to accommodate fabric patterns may vary substantially from the amount specified in the Price List. All of Seller's yardage estimates are based in 54 inch wide finished vinyls or fabrics. In the absence of instructions Seller will apply fabric pattern according to Seller's best judgement. If Purchaser must have exact yardage requirements, Purchaser must forward 120% of yardage for one Product (see yardage requirement in Price List) and a request yardage estimate. In most cases this will permit an accurate usage calculation.

All COM must be shipped prepaid and clearly marked with Purchaser's name purchase order number and Beaufrum Order Acknowledgment Number. Leather material is subject to a ten percent (10%) surcharge in upholstery work. Seller reserves the right to refuse any COM or require a written unconditional release prior to production of Products using the COM. All COM fabrics must pass CAL TB117-2013 and documentation for confirmation must be supplied to seller. Seller reserves the right to refuse any COM deemed unsuitable for upholstery and does not meet these requirements.

Seller's Limited Warranty does not cover the quality and durability of any upholstery materials, including COM, and Seller shall not be held responsible for wear, fading or performance of any upholstery or other materials, whether supplied by the Purchaser or by Seller. Seller is not responsible for any flaws or defects or variations in color of COM. Seller assumes no responsibility for the flame retardancy of any COM. Purchasers are solely responsible for making sure that COM complies with all applicable codes and regulations.

18. Product Returns: Written authorization ("Return Authorization") is required by Seller for Purchaser to return any Product. No credit is allowed for Products returned without such prior written consent by Seller. A Return Authorization sent to Purchaser by Seller must accompany all returned merchandise; otherwise shipment will be refused. Failure to enclose a Return Authorization and proper identification will result in credits being delayed. Returned Products are subject to a restocking charge of fifty percent (50%) of the purchase price of the Products. Products in orders that included upholstered merchandise (including, without limitation, Products made with COM), special material, manufacturing sizes, etc. are not returnable. Returns must be made within 15 days of the date of the Return Authorization.

19. Seller's Remedies: Seller retains the right upon breach of this Contract by the Purchaser to sell any Products in Seller's possession. In effecting any resale based upon breach of this Contract by Purchaser, the Purchaser shall remain liable for any net deficiency on resale of Product. Seller shall be entitled to collect from Purchaser reasonable attorney's fees and costs related to Purchaser's breach of this Contract.

20. Any stains or water rings should be wiped up immediately to help protect the surface of the top from marring & discoloration. Do NOT use bleach, ammonia, or chlorine or acid-based (citrus) cleaners. Acidic and chemically abrasive solutions will damage the finish of the wood surface.

Maintenance Instructions – Marble Table Tops

Marble table tops are anti-stain treated prior to leaving the factory. However, marble is a porous material. Food or liquid stains may occur if they are not removed immediately after happening. We recommend that the marble table top be re-treated with anti-stain at least twice per year. This is a simple procedure, and there are many available products on the market that will protect the marble during usage.

Maintenance Instructions – Laminate Table Tops

Following are general guidelines for the cleaning of laminate table tops. However, there are extensive cleaning instructions that you can get from the website of the laminate manufacturer (Nevamar, Wilsonart, and Formica) that detail specific table top finishes and many kinds of possible stains. Wipe tops using a clean, damp cloth or sponge with a mild soap, non-bleach detergent or a general purpose cleaner (Windex, Formula 409, PineSol, Dawn). Polishes and sealers are not recommended. Application of these products will cause a residue buildup. We do not recommend the use of any cleaners with bleach, abrasives, or anti-bacterial formulas that may damage the finish of the top. Do not flood the laminate top, especially near the seams, since water can penetrate and cause the substrate to swell. Wipe dry immediately after cleaning.

Maintenance Instructions – Urban Table Tops

Following are general guidelines for the cleaning of Urban table tops. Wipe tops using a clean, damp cloth or sponge with a mild soap, non-bleach detergent or a general purpose cleaner (Windex, Formula 409, PineSol, Dawn). Polishes and sealers are not recommended. Application of these products will cause a residue buildup. We do not recommend the use of any cleaners with bleach, abrasives, or anti-bacterial formulas that may damage the finish of the top. Wipe dry immediately after cleaning.

Maintenance Instructions – Aluminum / Stainless Steel

USING THE ALL WEATHER COLLECTION OUTDOORS: Due to the harsh climate (ocean, sand, weather, etc) that is experienced in some areas, we recommend the application of Duragloss Liquid Aluminum Polish # 881. The polish can be found

at most hardware and auto part stores. The polish is formulated to clean and polish all types of metal surfaces. It removes oxidation, tarnish, rust and soil. It leaves a protective coating, which resists future oxidation. We recommend re-application of the polish at least once per year.

Directions for application:

- 1) Apply metal polish using a 100% cotton cloth or pad
- 2) Allow to haze 4-5 minutes
- 3) Remove haze with a clean 100% cotton cloth

For application on tarnished items, use a soft wire cloth and apply extra pressure as needed, then wipe off with the cotton cloth.

Maintenance Instructions - Solid Surface (example: Avonite)

Matte Finish

Cleaning : A sponge, soap and water will clean most stains. For more stubborn stains use a green Scotch Brite pad and an abrasive cleanser. Periodically go over the entire matte surface with a dry green Scotch Brite pad to return the original finish. Scratches: To remove scratches, start sanding with 240 grit paper and then clean with an abrasive cleanser and a green Scotch Brite pad.

Satin Finish

Cleaning: Soap and water will clean most stains. For stubborn stains use a white Scotch Brite pad and a non-abrasive cleanser, such as Soft Scrub. Scratches: To remove scratches, start by sanding with 400 grit paper followed by 600 grit paper. Then clean the area with Soft Scrub and a white Scotch Brite pad. You may choose to spray a light coat of Protect All to enhance the luster. Scratches: To remove scratches, start by sanding with 400 grit paper followed by 600 grit paper. Then clean the area with Soft Scrub and a white Scotch Brite pad. You may choose to spray a light coat of Protect All to enhance the luster.

High Gloss

Cleaning: Soap and water will remove most stains. Use a polishing compound like 3M Perfect-It and a soft cloth to remove more stubborn stains. Scratches: To remove scratches from a high gloss finish, start sanding with 400 grit paper. The surface must then be machine polished back to its original finish. Advise customer to contact the AVONITE Surfaces Fabricator if they do not own or have access to this equipment.

Helpful Hints

- Always use a hot pad or trivet under hot pots or heat producing appliances.
- Always use a cutting board.
- Never stand on your counters.
- Avoid harsh chemicals such as drain cleaners and paint removers.
- For high gloss counters place felt protectors on the bottom of pottery or other hard objects.
- Avoid sliding hard objects across these glossy surfaces.
- Always run cool water when pouring boiling water into Avonite Surfaces sinks.

Maintenance Instructions - Varnished, Painted, or Powdercoated Metal Surfaces

Varnished, painted or powder coated metal surfaces must be cleaned ONLY with NON ABRASIVE and NON ACIDIC solutions. Only use mild soap, non bleach detergent or a general purpose cleaner such as Dawn soap. Polish and sealers are not recommended. We do not recommend the use of any cleaners with concentrated bleach, Citrus-type cleaner, abrasives, or anti bacterial formulas as they will damage the finish of the top and void any warranty.

Maintenance Instructions - Leather Upholstery

WEEKLY - dust your leather items weekly to keep pores free from dust particles. Wipe with a soft cloth. Clean stains immediately with a damp cloth and mild detergent. It is a good idea to have a leather cleaner on hand. QUARTERLY - you should use a high quality leather conditioner/preservative to protect the leather and keep it supple.

The sale or supply of any products and/or services by Seller, or its subsidiaries or affiliates, to the Purchaser is expressly conditioned upon the terms and conditions contained or referred to in this Contract. Any additional or different terms and conditions set forth in Purchaser's purchase order or other communication are objected to and will not be binding upon Seller unless specifically agreed to in writing by an officer of Seller. Any order or authorization by Purchaser, whether written or oral, for Seller to furnish products or services shall constitute acceptance of these terms and conditions. No modification to this Contract shall be effective against Seller unless evidenced in writing and signed by a duly authorized representative of Seller.

1. Definitions: "Seller" shall mean Beaufurn, LLC; "Purchaser" shall mean the person or entity listed on the order acknowledgment, and any subsidiary or affiliate of such person or entity receiving Products under the Contract; "Parties" shall mean the Purchaser and Seller, collectively; "Product(s)" shall mean the goods supplied pursuant to this Contract; "Contract" shall mean Beaufurn's order acknowledgment, these Terms and Conditions, and the Limited Warranty; and "Facility" shall mean any manufacturing or distribution facility operated by Seller.

2. Method of Payment: A 50% deposit is due from the Purchaser at the time of order of any Product. The balance is due before shipment of the Products and/or when the Products are ready to be shipped. All payments shall be paid in United States Dollars and may be payable via cash, check, wire, ACH, or credit card only.

3. Delivery and Risk of Loss: All prices of Products are Ex Works (Incoterms 2000) Seller's Facility in North Carolina. Title to and risk of loss of any Products sold hereunder shall pass to Purchaser upon Seller's delivery of the Products to the carrier at Seller's Facility. Seller is not responsible for loss or damage in transit. Purchaser shall bear the cost of freight from Seller's Facility to Purchaser's location. Performance shall be deemed to have occurred at the point of delivery to carrier at Seller's Facility.

4. Acceptance and Rejection: Promptly upon receipt of Products delivered hereunder, Purchaser shall carefully inspect such Products for any damage, defect, or shortage before signing the freight bill. All claims for shortage or nondelivery and any claim for damage or defect which could reasonably be discoverable in the course of such inspection shall be waived unless Purchaser shall notify Seller of the same within five (5) days after receipt of such shipment of Products to which the claim relates. If Purchaser rejects in whole or in part any nonconforming shipment of Products, Purchaser shall provide Seller written notice of such rejection not later than five (5) days after receipt of such shipment of Products. If Purchaser fails to provide Seller with such notice, Purchaser shall be deemed to have accepted the applicable shipment of Products. Upon written notice of nonconformity of any Product, Seller shall have the right to cure said nonconformity within a reasonable time. If Seller agrees with Purchaser's determination that a shipment of Products does not comply with applicable specifications, Seller shall use reasonable efforts to repair or replace the nonconforming Products, at no additional costs to Purchaser.

5. Product Specification and Prices: Seller reserves the right to alter product specifications without notice. Prices are subject to change without notice to Purchaser. All orders placed by Purchaser are subject to final confirmation by Seller. Seller is not responsible and will not honor incorrect quotations from independent representatives. All prices and other terms are subject to correction for typographical or clerical errors.

6. Product Dimensions: All advertised Product dimensions are subject to change without notice to Purchaser or Purchaser's consent. If dimensions are critical to Purchaser, Purchaser may advise Seller of such when ordering the Product(s). Seller will make reasonable efforts to comply with Purchaser's requests, however, Seller does not guarantee that the Product(s) will exactly conform to Purchaser's requests or the advertised dimensions.

7. Cancellations: All Products are finished to order and Purchaser shall have no right to cancel an order without first obtaining the prior written consent of Seller and the payment of the cancellation fee imposed by Seller. Seller will not consent to the cancellation by Purchaser of an order after production of such Products has begun.

8. Seller's Right to Sell Product: Possession of Seller's catalog and price list does not constitute authority to purchase or sell Products manufactured by Seller. Seller sells Products on a select dealership basis and reserves the right to decline orders from any prospective Purchaser or account.

9. Collection Costs: Purchaser agrees to be liable for all collection costs including, but not limited to, Seller's attorney's fees and costs. Overdue accounts shall be assessed a late payment fee at the rate of two percent (2%) per month or the maximum rate permitted by applicable law with respect to such obligations, whichever is less.

10. Product Shipment and Delivery: Seller will ship orders complete unless Purchaser's order acknowledgment specifically states "Split Ship" to indicate that all the Products should be shipped as they are complete in which case additional freight charges will be added to Purchaser's Invoice. Packaging charge, if any, is additional. Product delivery dates are not guaranteed. Seller assumes no liability in the event of any delivery delays.

11. Storage Charges: Postponement of shipment beyond Seller's scheduled ship date will result in a storage charge at the rate of two and one-half percent (2.5%) or Prime Rate + 1% whichever is higher per month on invoice total.

12. Minimum Order: Minimum quantity order may apply on some Product styles.

13. Taxes: Purchaser shall pay all taxes based on or in any way measured by this Contract or the Products, including any real or personal property taxes. If Seller is required to pay or collect any taxes on the Products, then all such amounts shall be paid by Purchaser or reimbursed by Purchaser to Seller.

14. Products Including Marble: For Products incorporating marble, Purchaser acknowledges and agrees that even though marble tops are anti-stain treated prior to leaving the factory, marble is a porous material and food or liquid stains may occur if they are not removed immediately after happening. Purchaser further acknowledges that Seller recommends that marble tops be re-treated with anti-stain at least twice a year using commercially available products. Purchaser acknowledges that marble is a natural product and will show natural variations in color and composition.

15. Table Top and Table Base Product: Purchaser acknowledges and agrees that recommended table top/base sizes are for reference only. It is Purchaser's sole responsibility to confirm sustainability for specific applications.

16. Products with Wood Finishes: Purchaser acknowledges and agrees that due to natural variations in the color of wood in its unfinished state, Products with wood finishes may show slight variations in color from any samples provided for review.

17. Products made with Purchaser's Own Material ("COM"): COM will be scheduled for production only after receipt and inspection of the COM by Seller. Purchaser acknowledges and agrees that in COM orders the actual yardage required to accommodate fabric patterns may vary substantially from the amount specified in the Price List. All of Seller's yardage estimates are based in 54 inch wide finished vinyls or fabrics. In the absence of instructions Seller will apply fabric pattern according to Seller's best judgement. If Purchaser must have exact yardage requirements, Purchaser must forward 120% of yardage for one Product (see yardage requirement in Price List) and a request yardage estimate. In most cases this will permit an accurate usage calculation.

All COM must be shipped prepaid and clearly marked with Purchaser's name purchase order number and Beaufurn Order Acknowledgment Number. Leather material is subject to a ten percent (10%) surcharge in upholstery work. Seller reserves the right to refuse any COM or require a written unconditional release prior to production of Products using the COM. All COM fabrics must pass CAL TB117-2013 and documentation for confirmation must be supplied to seller. Seller reserves the right to refuse any COM deemed unsuitable for upholstery and does not meet these requirements.

Seller's Limited Warranty does not cover the quality and durability of any upholstery materials, including COM, and Seller shall not be held responsible for wear, fading or performance of any upholstery or other materials, whether supplied by the Purchaser or by Seller. Seller is not responsible for any flaws or defects or variations in color of COM. Seller assumes no responsibility for the flame retardancy of any COM. Purchasers are solely responsible for making sure that COM complies with all applicable codes and regulations

18. Product Returns: Written authorization ("Return Authorization") is required by Seller for Purchaser to return any Product. No credit is allowed for Products returned without such prior written consent by Seller. A Return Authorization sent to Purchaser by Seller must accompany all returned merchandise; otherwise shipment will be refused. Failure to enclose

a Return Authorization and proper identification will result in credits being delayed. Returned Products are subject to a restocking charge of fifty percent (50%) of the purchase price of the Products. Products in orders that included upholstered merchandise (including, without limitation, Products made with COM), special material, manufacturing sizes, etc. are not returnable. Returns must be made within 15 days of the date of the Return Authorization.

19. Seller's Remedies: Seller retains the right upon breach of this Contract by the Purchaser to sell any Products in Seller's possession. In effecting any resale based upon breach of this Contract by Purchaser, the Purchaser shall remain liable for any net deficiency on resale of Product. Seller shall be entitled to collect from Purchaser reasonable attorney's fees and costs related to Purchaser's breach of this Contract.

20. Purchaser's Remedies: PURCHASER'S EXCLUSIVE REMEDY FOR SHORTAGE OF PRODUCT, DAMAGED OR DEFECTIVE PRODUCT (WHETHER OR NOT OCCURRING AS A RESULT OF SELLER'S ALLEGED NEGLIGENCE OR GROSS NEGLIGENCE), BREACH OF WARRANTY BY SELLER, OR ANY OTHER CAUSE OF ACTION ARISING OUT OF SELLER'S SALE OF PRODUCTS (WHETHER ARISING IN CONTRACT, TORT, STRICT LIABILITY OR UNDER ANY OTHER LEGAL THEORY) IS EXPRESSLY LIMITED TO REPAIR OR REPLACEMENT OF NONCONFORMING PRODUCTS, AT SELLER'S SOLE OPTION. PURCHASER SHALL HAVE NO RIGHT TO WITHHOLD PAYMENT OR MAKE A REDUCTION IN PRICE. PURCHASER'S REMEDY OF REPAIR OR REPLACEMENT IS AVAILABLE ONLY IF NONCONFORMANCE WAS NOT CAUSED BY PURCHASER'S MISUSE, NEGLIGENCE, IMPROPER STORAGE, OR TRANSPORTATION, OR BY ACCIDENT, FIRE OR OTHER HAZARD. PURCHASER'S REMEDY FOR BREACH OF WARRANTY BY SELLER SHALL BE LIMITED TO OBTAINING CONFORMING PRODUCTS FROM SELLER OR, AT SELLER'S OPTION, REPAIR OF SUCH NONCONFORMING PRODUCTS.

21. Limitation of Liability: IN NO EVENT SHALL SELLER OR ITS SUBCONTRACTORS BE LIABLE TO PURCHASER FOR ANY INCIDENTAL, CONSEQUENTIAL, INDIRECT OR SPECIAL DAMAGES, INCLUDING PUNITIVE OR TREBLE DAMAGES OR ATTORNEY'S FEES, WHETHER FORESEEABLE OR UNFORESEEABLE, BASED ON CLAIMS OF PURCHASER OR ITS CLIENTS OR CUSTOMERS (INCLUDING, BUT NOT LIMITED TO, CLAIMS FOR LOSS OF GOODWILL, PROFITS, USE OF MONEY OR USE OF PRODUCTS OR IMPAIRMENT OF OTHER ASSETS), ARISING OUT OF BREACH OF EXPRESS OR IMPLIED WARRANTY, BREACH OF CONTRACT, MISREPRESENTATION, NEGLIGENCE, GROSS NEGLIGENCE, STRICT LIABILITY IN TORT OR OTHERWISE IN CONNECTION WITH OR ARISING OUT OF THIS CONTRACT, EXCEPT IN THE CASE OF PERSONAL INJURY OR PROPERTY DAMAGE WHERE AND TO THE EXTENT THAT APPLICABLE LAW REQUIRES SUCH LIABILITY. TO THE EXTENT PERMITTED BY APPLICABLE LAW, PURCHASER'S RECOVERY FROM SELLER FOR ANY DAMAGES SHALL NOT EXCEED THE PRICE PURCHASER PAID TO SELLER FOR SUCH PRODUCT.

PURCHASER ASSUMES RESPONSIBILITY FOR ALL PERSONAL INJURY AND PROPERTY DAMAGE RESULTING FROM THE HANDLING, POSSESSION, USE, OR RESALE OF ANY PRODUCT. ANY ACTION BY PURCHASER FOR BREACH OF THIS CONTRACT BY SELLER OR ANY OTHER CAUSES OF ACTION OF PURCHASER EXPRESSLY ALLOWED UNDER THIS CONTRACT MUST BE COMMENCED WITHIN ONE YEAR AFTER THE CAUSE OF ACTION HAS ACCRUED.

22. Exclusive Warranty and Remedy: THE WARRANTIES AND REMEDIES SET FORTH HEREINABOVE ARE EXCLUSIVE, AND NO OTHER WARRANTY OR REMEDY OF ANY KIND, WHETHER STATUTORY, WRITTEN, ORAL, EXPRESS, OR IMPLIED, INCLUDING WITHOUT LIMITATION WARRANTIES OF PERFORMANCE, MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, SHALL APPLY. Seller makes no representation or warranty concerning the application or effect of any federal, state, national or local laws, ordinances, rules or regulations which may now or hereafter pertain to the installation, use or operation of the Products.

23. Indemnity: Purchaser agrees to indemnify, hold harmless and defend Seller and Seller's directors, officers, employees and agents, and the directors, officers, employees and agents of any Seller parent, subsidiary or related company (the "Seller Indemnities") from and against any and all claims, suits, losses, damages, costs, fees and expenses arising out of the death or injury to person or damage to property resulting from the sale, marketing or use of the Products by Purchaser, except to the extent that such claims, suits, losses, damages, costs, fees or expenses arise or result from any negligent or wrongful act or omission of Seller.

24. Force Majeure: No liability shall result from Seller's nonperformance or delay in performance hereunder, when due to (i) war (whether or not declared and whether or not the United States or the country in which Purchaser's place of business is located is a participant), act of the public enemy, act of God, riot, fire, explosion, flood, storm, accident, or sabotage; (ii) strike, lockout or other labor trouble (whether or not such labor trouble is within the reasonable control of Seller); (iii) compliance with any law, act, regulation, priority, request or recommendation of any governmental authority; (iv) unavailability, shortage or significant increase in the cost of fuel, raw materials, energy sources or labor; (v) mechanical failure or breakdown of equipment; or (vi) any contingency beyond the reasonable control of Seller

interfering with the production, supply, or transportation of the Products covered by the Contract or with the supply of raw materials used in connection therewith. In such event, quantities so affected will be eliminated from the Contract without liability to either Party thereof.

25. Miscellaneous:

- a. Remedies not Exclusive: All remedies available to the Parties for breach of obligations herein are cumulative and may be exercised concurrently or separately, and the exercise of any one remedy will not be deemed an election of such remedy to the exclusion of other remedies provided herein.
- b. Dispute Resolution: Any dispute between Seller and Purchaser arising under or related to this Contract other than disputes related to the Purchaser's failure to pay the amounts due hereunder shall be resolved by arbitration in Winston-Salem, North Carolina, USA, under the rules of the American Arbitration Association and under the laws of the State of North Carolina, excluding its choice of law rules. The United Nations Convention on Contracts for the International Sale of Goods shall not apply.
- c. Severability: In the event any provision of the Contract is held to be invalid or unenforceable, the valid or enforceable portion thereof and the remaining provisions of the Contract will remain in full force and effect.
- d. Waiver: A failure by either Party to insist on performance of any of the terms of the Contract, a failure by either party to exercise any right or privilege, or a waiver of any breach hereunder shall not constitute a waiver of any other right or privilege, whether of the same or similar type.
- e. Nonassignability; Binding on Successors: Except in connection with any sale of all or substantially all of Purchaser's assets, whether by merger or otherwise, any attempted assignment of the rights or delegation of the obligations under the Contract by Purchaser, whether by operation of law or otherwise, shall be void without the prior written consent of the Seller. In the case of any permitted assignment or transfer of or under the Contract, the Contract shall be binding upon, and inure to the benefit of, the successors, executors, heirs, representatives, administrators and assigns of the Parties hereto.
- f. Commercial Terms: Unless otherwise specifically provided on the face of the order acknowledgement, commercial trade terms used in the Contract shall be as defined in accordance with the North Carolina Uniform Commercial Code.
- g. Ambiguities: Ambiguities, if any, in the Contract shall not be construed against either Party, irrespective of which Party may be deemed to have authored the ambiguous provision.
- h. Survival of Obligations: Any termination of the Contract shall not affect any monies owing or obligations incurred by either of the Parties prior to the effective date of the termination. The representations and warranties set forth in this Contract shall survive expiration or termination for any reason of the Contract.

WARRANTY INFORMATION

LIMITED WARRANTY: INDOOR FURNITURE

1. Beaufurn, LLC (Seller) offers a Limited Warranty on indoor Chairs and Barstools ("Products") sold by the Seller to the original purchaser (Purchaser), covering defects in material and workmanship on the frame and base of products for a period of up to five (5) years from the date of invoice, subject to the terms, conditions and limitations described below. When other manufacturers warranties exist, Purchaser's claim must be made directly to those manufacturers, and all such warranties shall be in lieu of this Limited Warranty. Any such warranty shall be the sole warranty to the Purchaser.
2. Purchaser shall promptly notify Seller in writing of any alleged defect in any Product purchased from Seller, in reasonable detail to the satisfaction of Seller. Seller has the right to fully inspect any Product claimed defective before making a final determination of the claim.
3. Seller's sole liability under this Limited Warranty and Purchaser's exclusive remedy with respect thereto, arising out of the purchase, manufacture, installation or use of the Product, whether such liability is alleged to arise on account of contract (including breach of warranty), tort (including negligence), strict liability, or otherwise, shall be, at Seller's option, limited to the repair or replacement of any Product determined by Seller to be defective. Seller has sole discretion to determine which method will be used to correct any defects. Reimbursement for repairs locally made must be approved by Seller in writing in advance of the repairs. Purchaser and Seller agree that this remedy is the exclusive remedy available to Purchaser. No person or entity is authorized by Seller to make and Seller shall not be bound by any statement or representation as to the performance of Products other than as contained in this Limited Warranty. This Limited Warranty shall not be amended or altered except in a writing signed by Seller and Purchaser.
4. Claims for delays or damages occurring during transit or unloading of Products are to be made directly to the applicable freight carrier, and are not covered under this Limited Warranty. Seller will assist Purchaser in making such claims. This Limited Warranty does not cover, and no implied warranty shall be deemed to cover, any condition or damages resulting from: (1) normal wear and tear; (2) use of the Products beyond normal use, or in an application not recommended by any guidelines issued by Seller; (3) excessive use or misuse of the Products; (4) variations or changes in design of the Products; (5) excessive weight exposure; (6) improper handling, storage, neglect or abuse of the Products; (7) moisture exposure; (8) heat or excessive temperature exposure; (9) exposure to extreme weather conditions; (10) lack of maintenance in accordance with Seller's maintenance instructions; (11) improper maintenance in contravention of Seller's maintenance instructions; (12) outdoor use of any Products intended solely for indoor use; or (13) any other causes or occurrences beyond Seller's control and unrelated to the manufacturing process.
5. Unless specified otherwise in writing by Seller, this Limited Warranty does not cover, and no implied warranty shall be deemed to cover, any part of the Products that are constructed of fabric materials, granite materials, marble materials or glass materials. Table bases, wood, laminate, or solid surface table tops are covered for one (1) year only from the date of invoice. Unless specified otherwise in writing by Seller, this Limited Warranty covers wicker or woven materials for one (1) year only from the date of the invoice (regardless of any registration of Product as set forth below). Fabric materials are covered solely by the manufacturers of the fabric material.

6. DISCLAIMER OF OTHER WARRANTIES

LIMITED WARRANTY – OUTDOOR FURNITURE

1. Beaufurn, LLC (Seller) offers a limited warranty on outdoor furniture products (“Products”) sold by the Seller to the original purchaser (Purchaser), covering defects in material and workmanship on the frame and base of Products for a period of up to one (1) year from the date of invoice, subject to the terms, conditions and limitations described below. When other manufacturers warranties exist, Purchaser’s claim must be made directly to those manufacturers, and all such warranties shall be in lieu of this Limited Warranty. Any such warranty shall be the sole warranty to the Purchaser.

2. Purchaser shall promptly notify Seller in writing of any alleged defect in any Product purchased from Seller, in reasonable detail to the satisfaction of Seller. Seller has the right to fully inspect any Product claimed defective before making a final determination of the claim.

3. Seller’s sole liability under this Limited Warranty and Purchaser’s exclusive remedy with respect thereto, arising out of the purchase, manufacture, installation or use of the Product, whether such liability is alleged to arise on account of contract (including breach of warranty), tort (including negligence), strict liability, or otherwise, shall be, at Seller’s option, limited to the repair or replacement of any Product determined by Seller to be defective. Seller has sole discretion to determine which method will be used to correct any defects. Reimbursement for repairs locally made must be approved by Seller in writing in advance of the repairs. Purchaser and Seller agree that this remedy is the exclusive remedy available to Purchaser. No person or entity is authorized by Seller to make and Seller shall not be bound by any statement or representation as to the performance of Products other than as contained in this Limited Warranty. This Limited Warranty shall not be amended or altered except in a writing signed by Seller and Purchaser.

4. Claims for delays or damages occurring during transit or unloading of Products are to be made directly to the applicable freight carrier, and are not covered under this Limited Warranty. Seller will assist Purchaser in making such claims. This Limited Warranty is strictly limited to the frame and base of Products and does not cover, and no implied warranty shall be deemed to cover any condition or damages resulting from: (1) normal wear and tear; (2) use of the Products beyond normal use, or in an application not recommended by any guidelines issued by Seller; (3) excessive use or misuse of the Products; (4) variations or changes in design of the Products; (5) excessive weight exposure; (6) improper handling, storage, neglect or abuse of the Products; (7) excessive moisture exposure; (8) excessive heat or excessive temperature exposure; (9) exposure to extreme weather conditions; (10) lack of maintenance in accordance with Seller’s maintenance instructions; (11) improper maintenance in contravention of Seller’s maintenance instructions; or (12) any other causes or occurrences beyond Seller’s control and unrelated to the manufacturing process. Unless specified otherwise in writing by Seller, this Limited Warranty does not cover, and no implied warranty shall be deemed to cover, any part of the Products that are constructed of fabric materials, granite materials, marble materials or glass materials. Unless specified otherwise in writing by Seller, this Limited Warranty covers woven materials and wicker materials for one (1) year only from the date of the invoice. This Limited Warranty does not cover surface cracks in wood products that do not affect the structural integrity of the Products. Surface cracks in certain wood materials are normal and to be expected when the Products are subjected to outdoor use.

MAINTENANCE

SL MAINTENANCE INSTRUCTIONS

Thank you for choosing our furniture for your establishment. We would like to do our best to ensure that our quality standards meet to your satisfaction. Please be advised of the following recommendations regarding maintenance and care of your furniture:

The furniture is made to withstand normal wear and tear under normal conditions. It is recommended that users make periodic inspections to look for damages or signs of structural fatigue incurred in daily handling and use. Loose screws should be tightened immediately and any product that needs repair should be taken out of service immediately for repair or replacement.

Maintenance Instructions - Chairs & Barstools

Only water, with or without soap, should be used for cleaning non-wooden chairs. Wooden chairs should be wiped with a cloth or cleaned with furniture polish.

Maintenance Instructions - French Bistro Collection

If the French Bistro chairs and table bases are used outdoors, we recommend that the frames be lightly sanded and re-varnished once a year with any commercial outdoor spray lacquer. Make sure you replace any missing glides immediately. Not recommended to keep outside in rain, sleet, snow, etc. During wintertime and in any inclement weather conditions, the chairs and tables should be covered and stored away.

Maintenance Instructions - PolyTeak Table Tops & Chairs

Our polyteak table tops and chairs are suitable for outdoor use. For cleaning use only soap and water, no ammonia or acid based cleaners as these will damage the surface.

Maintenance Instructions - Teak Table Tops & Chairs

Our teak wood table tops and chairs are suitable for outdoor use. Teak is a natural product and should be treated regularly with varnish, teak oil, or any top coat material, to maintain the original teak wood product.

Maintenance Instructions - Werzalit Molded Table Tops

Our Werzalit molded tops are resistant to most chemicals and cleaning fluids and are easy to wipe clean. However, we recommend using a mild soap or detergent for cleaning. Do not use any abrasive cleaners or cloths. Please also read Werzalit Top Information Sheet.

Maintenance Instructions - Wood Veneer or Solid Wood Table Tops

Suggested cleaning includes mix of mild soap and warm water; apply only with a cloth and dry immediately after cleaning. Any stains or water rings should be wiped up immediately to help protect the surface of the top from marring & discoloration. Do NOT use bleach, ammonia, or chlorine or acid-based (citrus) cleaners. Acidic and chemically abrasive solutions will damage the finish of the wood surface.

Maintenance Instructions - Marble Table Tops

Marble table tops are anti-stain treated prior to leaving the factory. However, marble is a porous material. Food or liquid stains may occur if they are not removed immediately after happening. We recommend that the marble table top be re-treated with anti-stain at least twice per year. This is a simple procedure, and there are many available products on the market that will protect the marble during usage.

Maintenance Instructions - Laminate Table Tops

Following are general guidelines for the cleaning of laminate table tops. However, there are extensive cleaning instructions that you can get from the website of the laminate manufacturer (Nevamar, Wilsonart, and Formica) that detail specific table top finishes and many kinds of possible stains. Wipe tops using a clean, damp cloth or sponge with a mild soap, non-bleach detergent or a general purpose cleaner (Windex, Formula 409, PineSol, Dawn). Polishes and sealers are not recommended. Application of these products will cause a residue buildup. We do not recommend the use of any cleaners with bleach, abrasives, or anti-bacterial formulas that may damage the finish of the top. Do not flood the laminate top, especially near the seams, since water can penetrate and cause the substrate to swell. Wipe dry immediately after cleaning.

Maintenance Instructions - Aluminum / Stainless Steel

USING THE ALL WEATHER COLLECTION OUTDOORS: Due to the harsh climate (ocean, sand, weather, etc) that is experienced in some areas, we recommend the application of Duragloss Liquid Aluminum Polish # 881. The polish can be found at most hardware and auto part stores. The polish is formulated to clean and polish all types of metal surfaces. It removes oxidation, tarnish, rust and soil. It leaves a protective coating, which resists future oxidation. We recommend re-application of the polish at least once per year.

Directions for application:

- 1) Apply metal polish using a 100% cotton cloth or pad
- 2) Allow to haze 4-5 minutes
- 3) Remove haze with a clean 100% cotton cloth

For application on tarnished items, use a soft wire cloth and apply extra pressure as needed, then wipe off with the cotton cloth.

Maintenance Instructions - Solid Surface (example: Avonite)

Matte Finish

Cleaning : A sponge, soap and water will clean most stains. For more stubborn stains use a green Scotch Brite pad and an abrasive cleanser. Periodically go over the entire matte surface with a dry green Scotch Brite pad to return the original finish. Scratches: To

remove scratches, start sanding with 240 grit paper and then clean with an abrasive cleanser and a green Scotch Brite pad.

Satin Finish

Cleaning: Soap and water will clean most stains. For stubborn stains use a white Scotch Brite pad and a non-abrasive cleanser, such as Soft Scrub. Scratches: To remove scratches, start by sanding with 400 grit paper followed by 600 grit paper. Then clean the area with Soft Scrub and a white Scotch Brite pad. You may choose to spray a light coat of Protect All to enhance the luster. Scratches: To remove scratches, start by sanding with 400 grit paper followed by 600 grit paper. Then clean the area with Soft Scrub and a white Scotch Brite pad. You may choose to spray a light coat of Protect All to enhance the luster.

High Gloss

Cleaning: Soap and water will remove most stains. Use a polishing compound like 3M Perfect-It and a soft cloth to remove more stubborn stains. Scratches: To remove scratches from a high gloss finish, start sanding with 400 grit paper. The surface must then be machine polished back to its original finish. Advise customer to contact the AVONITE Surfaces Fabricator if they do not own or have access to this equipment.

Helpful Hints

- Always use a hot pad or trivet under hot pots or heat producing appliances.
- Always use a cutting board.
- Never stand on your counters.
- Avoid harsh chemicals such as drain cleaners and paint removers.
- For high gloss counters place felt protectors on the bottom of pottery or other hard objects.
- Avoid sliding hard objects across these glossy surfaces.
- Always run cool water when pouring boiling water into Avonite Surfaces sinks.

Maintenance Instructions - Varnished, Painted, or Powdercoated Metal Surfaces

Varnished, painted or powder coated metal surfaces must be cleaned ONLY with NON ABRASIVE and NON ACIDIC solutions. Only use mild soap, non bleach detergent or a general purpose cleaner such as Dawn soap. Polish and sealers are not recommended. We do not recommend the use of any cleaners with concentrated bleach, Citrus-type cleaner, abrasives, or anti bacterial formulas as they will damage the finish of the top and void any warranty.

Maintenance Instructions - Leather Upholstery

WEEKLY - dust your leather items weekly to keep pores free from dust particles. Wipe with a soft cloth. Clean stains immediately with a damp cloth and mild detergent. It is a good idea to have a leather cleaner on hand. QUARTERLY - you should use a high quality leather conditioner/preservative to protect the leather and keep it supple.

Maintenance Instructions - Case goods

Just as trees in the forest are not the same, each individual piece of furniture has markings that will differ from piece to piece. Mineral streaks, grain variations, knots, small pits, and other marks of nature are normally found in fine woods and are not considered defects. Variations cannot be controlled or corrected and will even occur among pieces within a set. On some items we intentionally dent, discolor and scratch the wood to create an aged appearance. Techniques used include physically marking the surface with a blunt instrument, marking with darker stain and splattering with stain. An aged appearance is sometimes achieved by rubbing pumice or a similar medium into wood pores. The number and nature of distress marks are a matter of design by the manufacturer and cannot be changed, nor is it an option that can be deleted.

Door Warping

It is important to properly close the doors and not allow them to hang open. Long periods of varying humidity can also produce warping. High humidity causes expansion; low humidity causes contraction. The client is responsible to keep doors closed when not in use, as well as to keep a reasonably stable level of humidity in the home to avoid warping problems.

Normal Changes Over Time

Wood finishes will change in appearance as they are used. Items with low sheen finishes tend to develop an increased sheen over time. Slight variations in appearance and the fit of joints and seams will result from the normal expansion and contraction of wood as it responds to climatic changes in the home. Many wood species darken or redden with age. White painted finishes tend to yellow with age. These changes in tone, fit, finish, and texture are normal signs of aging and are not covered by any warranty.

Reclaimed Wood

Reclaimed lumber is collected from old structures and used in making new pieces of furniture. Each board will vary in surface texture and color shading. There may be natural splits and cracks visible. Holes where nails, bolts or hinges were applied may be open and may exhibit signs of rust around them. Large holes may be "plugged" with a wood insert. All of these features add to the unique individual character of the furniture and are not considered defects.

Cleaning

Dust lightly using a soft terry cloth with the grain of the wood. To remove minor stains or caked on dirt, wipe with a soft damp cloth. Oily stains can be removed using a cloth damp with a mixture of warm water and Murphy's soap. Dry the piece thoroughly with a clean, soft cloth. To avoid scratch-ing, you should blot, rather than wipe spills.

Sun Exposure

Overexposure to sunlight can adversely affect wood finishes, causing cracking and bleaching that are difficult and costly to repair.
